Snowmobiling ADVENTURE RELEASE, WAIVER & ASSUMPTION OF RISKS

I, _____ hereby grant permission to participate in Follow Her North's adventure and represent that I am physically able to participate in this type of activities. I hereby release Follow Her North and its employees and volunteers from all claims resulting from illness, injuries, or other incidence that may be sustained during the adventure. In the event of illness or injury, I hereby authorize the staff members to obtain medical assistance or any other appropriate treatment. Considering the services provided and the equipment used by Follow Her North, I agree to participate in wilderness survival-related outdoor activities and hands-on learning.

I agree as follows:

I UNDERSTAND that adventures involve walking through the bush, performing activities in the proximity of plants, insects, and animals under the supervision of Follow Her North.

I am AWARE that taking part in this activity involves a certain level of risk, including but not limited to developing allergies, falling in the water and drowning, burning yourself around a campfire, sunburns, mosquito bites, frost bites, minor injuries as a result of trips and falls or walking in the forest, losing or damaging clothing and other personal items, etc. I ACKNOWLEDGE all risks involved and willingly ASSUME the same.

I am aware that Snowmobiling involves many inherent risks, dangers and hazards, including but not limited to: exposed rock, earth, ice or other natural objects; trees, tree wells, tree stumps, forest deadfall; holes and depressions on or beneath the snow surface; variable and difficult snow conditions; changes or variations in the terrain which may create blind spots or areas of reduced visibility; streams, creeks and holes in the snow pack above stream or creeks; cliffs; crevasses; winter travel on back-country roads; snowcat roads, road-banks and cut-banks; impact or collision with other snowmobiles and vehicles, becoming lost or separated from the guides or other participants; mechanical failure of snowmobiles and related equipment; extreme and rapidly changing weather conditions; encounter with wildlife including bears; the failure to operate a snowmobile safely or within one's own ability; negligence of other snowmobilers and other persons; AND NEGLIGENCE ON THE PART OF THE RELEASEES, INCLUDING THE FAILURE BY THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE. Communication in the backcountry may be difficult, and in the event of an accident, rescue, medical treatment and evacuation may not be available or may be delayed. Backcountry weather conditions may be extreme and can change rapidly and without warning.

I AGREE to release Follow Her North from all claims for money damages. I AGREE to release Follow Her North from all unintended harm to myself resulting from adventure activities.

I AGREE that Follow Her North may document my participation in this event on video or by photograph. I grant Follow Her North the use of any such recordings to be used for promotional materials ONLY. Such recordings are the sole property of Follow Her North.

I UNDERSTAND that FOLLOW HER NORTH encompasses its owner and operator, volunteers and sponsors.

I DECLARE that I AGREE to all of the above-noted provisions, and I will-assume all the obligations of this Release.

BY SIGNING BELOW, I forever release and discharge Follow Her North, its employees for any liability that may occur during an adventure.

On behalf of myself and of my family, the undersigned has read and voluntarily signs this release and waiver of liability and indemnity agreement. I agree that no oral representations, statements, or inducements apart from the forgoing written agreement have been made.
